

# Voting System Post Election Audit Report

County: Hernando

Date of Election: August 26, 2008

Precinct Numbers: 20 & 50

Race: School Board Member, Dist #4

**1. Overall accuracy of the audit:**

Excellent

**2. Description of any problems or discrepancies encountered:**

Precinct 20's count was off by one (1). The precinct clerk indicated on the ballot accounting form that one ballot was counted twice. It was due to poll worker error not reading the LCD screen on the Accu-vote unit indicating that the ballot had already been read, so he put it back through the reader a second time. By doing so, it increased the vote for one candidate by one (1).

**3. Likely cause of such problems or discrepancies:**

Poll worker should not have put the ballot back through the counter.

**4. Recommended corrective action with respect to avoiding or mitigating such circumstances in future elections:**

Poll worker training on how to read the LCD screen on AccuVote unit more accurately.






