FREQUENTLY ASKED QUESTIONS

Can I use my voter information card as ID when I go to vote? No. It is not an acceptable form of ID for voting. You must provide photo and signature ID. F.S. 101.043

Will I be selected for jury duty if I register to vote? No. Jurors are selected from DMV records, not from voter registration records.

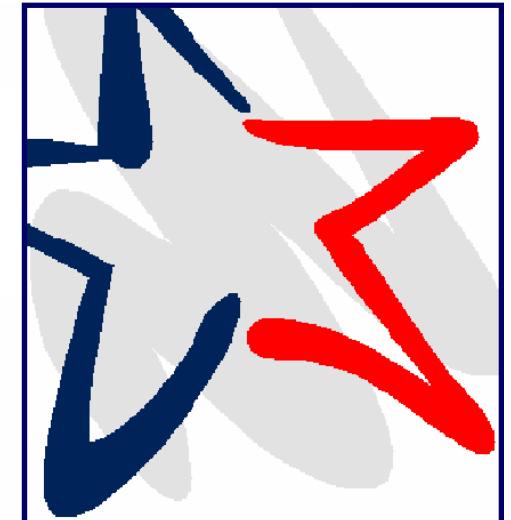
If I don't vote in every race, will my ballot count? Yes. All the races that you choose to vote in will be counted.

Can I register to vote online? No. However, you can fill out a voter registration application form online, print it, sign it and mail it to the Elections office.

If I vote by absentee, will my ballot be counted? YES! All absentee ballots are counted on Election Day.

When can I change my party? You can change your party no less than 29 days prior to an election using a Florida voter registration application.

Since Florida is a "closed primary state," does that mean that I can't vote in a primary election if I don't belong to a political party? No. You will receive a non-partisan ballot to vote on non-partisan races and issues. Those registered with a minor party will receive a non-partisan ballot, unless that party has a run-off. If you belong to a major party, you will receive that party's ballot.
